Mr S.Ali, Sr.C.G.S.C for respondents on notice.

Since the learned counsel argued that this is a genuine case where the applicant believes that great injustice has been done to him in the matter of his due promotion , we carefully considered the matter in some detail and discussed various aspects relating to it with the counsel. We however, regret our inability to admit the application for following reasons :

The grievance of the applicant is that while he was working as a Sorter in the Railway Mail Service Wing, N.E. Circle, Shillong he appeared for the departmental examination for promotion to the cadre of Inspector RMS held in the year 1976. However, he was not given promotion in pursuance of that examination as all the four vacancies were filled up upto serial No.3 whereas his serial number was 4 amongst the qualified





candidates. However, according to him during the currency of the ^{panel} ~~panel~~ for one year another post fell vacant due to promotion of some officer and he should have been appointed against that post but was illegally deprived of that opportunity. The applicant therefore prays that the respondents may be directed to appoint him to the promotional post of Inspector with retrospective effect. Evidently the grievance relates to the year 1976. It appears that the applicant had filed a representation to the General Manager, N.E. Telecom. Circle on 7.4.77 and that was rejected by the Director General on 17.9.1977 and copy was sent to the applicant on 24.6.78. It was only after a lapse of about 10 years that on 4.5.88 the applicant filed another representation. Although he was a regular employee of the department and was not without any source of income he stated in the representation that it was a case of poor employee. Thereafter the applicant has placed his case before the Staff Adalat held on 30.9.92 and that being forwarded to the Adalat at Shillong, the request of the applicant for re-consideration of the matter was rejected on 13.10.93. It was stated that it was not feasible to consider the case after a lapse of more than 17 years. It is thereafter after a lapse of about 2 years the Tribunal has been approached, simply because once more the applicant was informed on 12.5.95 relating to the proceeding before the Staff Adalat that it was too late to do anything to consider his case, ~~that the applicant has approached the Tribunal.~~ During all these periods the applicant has already been promoted as Senior Accountant in the office of the Chief General Manager, Telecom., Assam Circle.



6. Facts of the case :

1. That the humble applicant was initially appointed as Sorter in the Railway Mail Service (RMS) Wing N.E. Circle, Shillong on 1-6-1967 and Posted at Guwahati in ~~xxxx~~ August 1975. The applicant appeared in the departmental promotion examination to the cadre of Inspector, RMS and ~~he~~ qualified in the said examination under Roll No. NE-140 along with other five candidates and the applicant's position was 4th in the selection list. The applicant secured the following marks in the aforesaid examination.

1st paper - 45, 2nd paper - 55
3rd paper - 59, 4th paper - 70
& 5th paper - 65.

The candidates who qualified in the said examination are also mentioned below in order of merit:-

2. That the first two candidates viz. S/Shri G.G. Singh and R.C. Chakraborty were appointed as Inspector (RMS) by the Post Master General, N.E. Circle, Shillong, following the declaration of the result against two other category vacancies (out of three notified vacancies, two other category and one Scheduled Caste vacancies). As no S/C candidate qualified in the aforesaid examination and the post was lying vacant for three consecutive years, the post was dereserved by the Deptt. under the pressure of Service Union and the third successful candidate viz. Shri Bijoy Bhusan Roy Choudhury, who was on deputation to Army Postal Service, was called back and appointed in that post after departmental examination of 1976 for Inspector (RMS) was held in which the above reserved S/C post was also notified.

3. That during the next twelve months following declaration of result of 1975 IRM-ship examination, one other category vacancy occurred under N.E. Circle, Shillong, consequent upon promotion of Shri M.M. Deb, ASRM to PSS Class-II Cadre. As per Rule 279/1 of Post & Telegraph Manual (Vol-IV, 4th Edition) the Director General could fill up the said vacancy by the qualified candidates of last 1975 examination. Accordingly, the applicant being the number one in the waiting list prayed to the post Master General, N.E. Circle, Shillong, to accommodate him against the said vacancy of Inspector/RMS vide his letter dtd. 1-3-1976

against the vacancy occurred during next 12 months. But PMG, Shillong did not accede to the genuine request of the applicant and thus deprived the applicant from his legitimate claim.

Copy of cited above is annexed as Annexure-II.

4. That the applicant thereafter appealed to the Director General, Department of Posts & Telegraph, New Delhi on 7-4-77 through proper channel to consider his prayer for appointment as Inspector/RMS against the vacancy ^{occurred} within next 12 months. Director General also rejected applicant's prayer vide his letter No.7/53/76-SPB dtd. 1-9-77 (conveyed to the applicant vide G.M. N.E. Circle letter No. STB-8/TAC ^{dt. 17.9.77}). The applicant further prayed to the Director General, P & T, New Delhi on 4-5-1988 and 11-4-90 to accommodate him against existing vacancies as the applicant's claim was genuine. But the D.G., New Delhi sat over the matter. The applicant's grievance remained unredressed.

Copy of D.G. letter dated 1-9-77 and applicants request dtd. 4-5-88 are annexed as Annexure- III & IV respectively.

5. That after constitution of Staff Adalat at Guwahati for redressal of grievances of P & T employees, the applicant submitted his appeal to the Chairman, staff Adalat, Assam Circle, Guwahati vide his letter dtd. 20-8-92 for redressal of applicants genuine

grievance. As the office of PMG at Guwahati came into existence in the year 1988, the Secretary Staff Adalat forwarded the applicant's grievance to the Chief Post Master General, N.E. Circle, Shillong for consideration.

Copy of applicants letter dated 20-8-92 and Staff Adalat Secretary's endorsement No.SA/3-28/92 dated 29-10-92 are annexed as Annexure- V & VI respectively.

6. That on persistent appeal to the Chairman, Staff Adalat, N.E. Circle, Shillong to consider the applicants' case, the Asstt. Post Master General(s), Shillong informed the applicant to furnish complete documents in support of the applicant's claim and accordingly the applicant furnished all details to the Chief Post Master General Shillong in this regard vide his letter dated 21-10-93.

Copy of APMG(S) letter No.Staff/109-6/92 dated 13-10-93 & copy of applicant's letter dated 21-10-93 are annexed as Annexure- VII & VIII respectively.

7. That to the utter surprise of the applicant after about one & half year, APMG, N.E. Circle, Shillong sent a vague reply to the applicant vide his letter No.Staff/109-6-/92 dated 12-5-95 regretting to consider the case of the applicant on the plea that all records of 1975 Exam. were weeded out long ago.

In this connection it may be mentioned that both CPMG, Shillong and Director General, ^{FLT}New Delhi made gross irregularities in appointing candidates as Inspector

(RMS) flouting departmental rules right from 1975 to 1978. Annexure-V may kindly be seen in this connection.

and approved Sri G.G.Singh & Sri R.C.Chakraborty being qualified candidate No.1 & 2 out of total 5 qualified candidates in merit list, _____ marks communicated on 23.2.76 vide (Annexure-2) _____ Representation submitted by qualified candidate No.3&4 (namely S/Sri Bijoy Bhushan Roy Choudhury & Mihir Kanti Paul) on 1.3.76 (vide Ann-3) showing two points (one for dereservation vide Ann.4 & to fill up one vacancy and the other for approving a candidate from waiting list by virtue of Rule 279/1 para-2 of P&T Manual Vol-IV to fill up the post caused due to promotion of Sri M.M.Deb to PSS Class-II on 19.4.76 (vide Annx-5). After that Sri Rabindra Ch.Das SC candidate of 1976 learnt that he was not declared qualified against the notified post inspite of getting pass mark & took up case incidentally, another post of IRM was suddently fallen vacant due to death of Rupdhar Das, IRM/GH-2nd Sub.Dev. Tezpur just after completion of IRM/1976 Exam. To satisfy Sri Rabindra Ch. Das who created pressure otherwise, DG.P&T/ND approved Sri Rabindra Ch. Das through supplementary result vide No.7-5/76-DE. Roy Choudhury was approved by DG.P&T,ND(vide Annux-II). But subsequently the DG.P&T,ND was very kind to re-approved the candidature of Sri Nikhil Ranjan Dey against the post for which Exam. &78 was called for. As a result, Sri D.K. Roy Choudhury promotion was in excess but accommodated him against no post. It is clear that against one declared vacancy, two IRMs approved. Still then case of Sri M.K. Paul was not accepted yet.

The above noted prima-facie history in filling No IRM post irregularly depriving the legitimate claim of Sri M.K. Paul 4th Q/Candidate of 1975 Exam. is furnished in a tabular form from 1972 to 1978 (vide Annux. 12&13) to you for your kind investigation so that your high hand will rescue me from the mental sufferings caused due to the wrong done in my case.

5. That Sir, I was representing time to time & lastly represented on 4.5.88 and followed by reminder on 11.4.90 which forwarded by CGMT/GH-7/ND ESTQ-5/73 dt 19.6.90 to DG (Postal) Deptt of Posts, Dak Bhawan, New Delhi, (Vide Annux. 14&15), but till date no communication is received.

Under the above circumstances, I hope that your honour would be kind enough to see the case and offer justice so that a poor Govt. servant gets his legitimate claim for which act of your kindness I shall remain ever grateful to you.
