

The humble petition of the abovenamed petitioner most ~~resp~~ respectfully sheweth :-

1. That your petitioner approached this Hon'ble Tribunal through O.A. No. 59/96 praying for a direction upon the respondents for redeputation of the appointment of the training <sup>for 42</sup> ~~for 2 (two)~~ facilitate promotional post of J.T.O (Junior Telecom Officer) and also for setting aside the condition of asking the applicant to work in the <sup>N.E.</sup> ~~any~~ circle on completion of the training and also Praying for <sup>direction</sup> upon the respondents for counting his seniority along with the batch mates <sup>with whom</sup> he had received training earlier treating him as candidate of 1985 batch. The respondents have duly contested the case before this Hon'ble Tribunal and the Hon'ble Tribunal have finally decided the matter on 2.7.97. The Hon'ble Tribunal was pleased to set aside the condition of asking the applicant to work in the <sup>N.E.</sup> ~~any~~ circle. The Hon'ble Tribunal was further pleased to direct the respondents regarding the question of counting the seniority the relevent portion of the direction passed by the Hon'ble Tribunal is quoted below :-

A

" ~~Para 5~~ considering all the aspects of the matter we find that the condition of asking the applicant to work in the N.E. Circle is not just, proper and fair. According to us it was an arbitrary act of the respondents. Therefore, we hold that the imposition of such a condition cannot sustain in law. Accordingly we set aside the condition that he should work in the N.E. Circle after completion of the training. So far as the second condition is concerned, namely, that he shall be made junior to the other persons, we, however, are not inclined to pass a reasoned order as to why he should be made junior to the other persons who had participated in the training earlier. This must be done as early as possible, at any rate within two months from the date of receipt of this order."

But the respondents/contempner did not take any action as regard the implementation of the order dated 2.7.97 passed by the Hon'ble Tribunal No. 59/96. In this connection it may be categorically stated that the Hon'ble Tribunal directed the contempner to pass a reason order as to why the applicant should be made junior to the other persons <sup>who</sup> had participated in the training earlier, but <sup>✓</sup> unfortunately, although the judgement & order was passed

on 2.7.97 and the same was duly informed to the contempner, even by the applicant through his representation dated 28.7.97 enclosing a copy of the judgement & order dated 2.7.97 but no decision was communicated to the petitioner regarding his seniority. Be it stated that the contempner had received the judgement & order dated 2.7.97 in the month of July itself and now it is more than 3 months <sup>have</sup> elapsed but no action was initiated with a deliberate intention by the contempner.

A copy of the judgement & order dated 2.7.97 and representation dated 28.7.97 are ~~endorsed~~ <sup>enclosed</sup> as Annexure - A & B.

2. That the contempner did not comply with the judgement & order dated 2.7.97 willfully and thereby violated the Hon'ble Tribunal order dated 2.7.97 passed by the Hon'ble Tribunal No. 59/96, which is amount to contempt of court and therefore the Hon'ble Tribunal be pleased to initiate the contempt proceeding against the contempner for willful violation and non-compliance of the judgement & order dated 2.7.97 passed by the Hon'ble Tribunal No. 59/96.

3. That your petitioner beg to state that although contempner No.2 was not initially impleaded as respondent in the Original application, but he was impleaded in the

contempt petition on the ground that he is the Asstt. Director of the Legal Cell and he is the competent authority for implementation of the Hon'ble Tribunal's order dated 2.7.97. Hence, B.C. Paul <sup>is</sup> as impleaded as contempner as contempt petition.

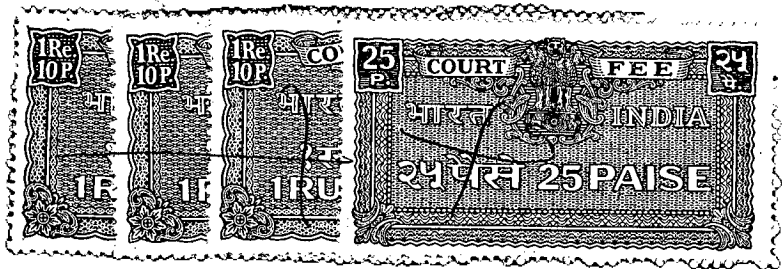
4. That this petition is made bonafide and for the ends of justice.

BARUAH.J. (V.C.)

In this application, the applicant has prayed for issuance of appropriate direction to the respondents.

2. Facts for the purpose of disposal of this application are:

In 1975 the applicant was appointed Phone Inspector. His next promotional avenue was Junior Telecom Officer (for short JTO). The applicant was selected in the qualifying departmental

examination in the year 1985. He was to undergo training for the post of JTO at Jabbalpur. The training was for a period of thirtyseven weeks. The applicant, however, could complete only thirtytwo weeks as he fell sick and as a result he was compelled to return. The training was necessary for the purpose of promotion and it was the duty of the department also to make necessary arrangements for imparting the training. As the applicant could not complete the training because of his illness the applicant approached the competent authority by submitting representation. On 10.9.1991, the applicant was allowed to resume his training for the second time. However, this time the authority imposed the conditions that on successful completion of the period of training the applicant would be required to serve in the N.E. Circle and also he shall be made junior to the other persons who received the training. According to the applicant this imposition of conditions is illegal, unreasonable and unfair. Hence the present application.

3. We have heard Mr. J.L. Sarkar, learned counsel for the applicant and Mr S. Ali, learned Sr. C.G.S.C. Mr Sarkar submits that the imposition of the conditions, namely, that the applicant would be required to work in the N.E. Circle and that he shall be junior to the other candidates who received training earlier, was not in accordance with the provision of rules. The learned counsel further submits that there is no such rule enabling the authority to impose such conditions. Mr Sarkar also submits that no such conditions were imposed on the persons who were sent for training earlier and also subsequently. Mr. S. Ali, on the other hand, supports the impugned action of the respondents. According to Mr Ali the imposition of condition was reasonable and just.

4. On the rival contention of the parties it is now to be seen whether the authority could impose such conditions. The admitted fact is that the authority imposed two conditions, namely, that the applicant, after completion of the period of training would be required to work in N.E. Circle, and that he should be made junior to the other persons who received training earlier. So far the first condition is concerned there is no such provision under the rules. At least Mr Ali has not been able to show anything in that regard. Such conditions had not been imposed on the other candidates.

1) That your alleged Contemner has full respect and regards to the Hon'ble Tribunal and has no intention to disobey and disrespect to the Hon'ble Tribunal's order particularly, the present order dated 02-07-97 passed in O.A. No. 59/97 by the Hon'ble Tribunal .

2) That after going through the judgment & order dated 02-07-97 passed by the Hon'ble Tribunal it was found that some important points of facts and points of law were not raised at the time of advancing the arguments by the learned Sr. C.G.S.C. in the case. That apart, he was also not properly briefed by the Department with regard to those points, namely, that the original applicant is an employee of the Assam Circle and served as phone Inspector and not as Junior Telecom Officer. Before bifurcation of North Eastern Circle in to 2(two) circles , that is, North Eastern Circle and Assam Circle the original applicant appeared in qualifying examination of Junior Telecom Officer from undivided North Eastern Circle, Shillong as his name was enlisted for undergoing training of Junior Telecom Officer ( J.T.O.) by the North Eastern (N.E.) Circle . During that time though he qualified for undergoing training but he was not sent for the said training , not only the present applicant but also his other batch-mates. The original applicant opted for Assam Circle as Phone Inspector and not as J.T.O. which is a higher post than the Phone Inspector.

That, these facts were also suppressed by the original applicant and hence the

alleged contemner has filed Review Application before the Hon'ble Tribunal against the judgment & Order dated 02-07-97 passed in O.A. No. 59/97 and the said Review Application is now pending before the Hon'ble Tribunal for consideration and decision.

3) That it may further be mentioned here that after bifurcation the J.T.O list for Assam Circle and N.E. Circle was prepared and published by the N.E. Circle and in the said list the Original applicant was included in the N.E. Circle list and his name was ~~not~~ appeared at Sl. No. 191 and his name did not find place in Assam Circle as J.T.O. It is worth to mention in this connection that the original applicant was also appeared in the qualifying examination for J.T.O from Assam Circle on 29-01-95 He has also been selected for undergoing the Training of J.T.O from Assam Circle but he could not be sent as vigilance case has been pending against him.

Annexure - I is the photocopy of select list for JTO Training published by N.E. Circle.

Annexure - II is the photocopy of Select List for J.T.O. Training published by Assam Circle.

4) That with regard to the statements made in paragraph 1 of the Contempt Petition the alleged Contemner has no comments the same being matters of record. The alleged contemner further begs to state that, it is not a fact that the alleged contemner has not taken steps against the order dated 02-07-97 passed in O.A. No. 59/97 by the Hon'ble Tribunal but in fact, the alleged contemner was not in a position to send him for training of J.T.O. as vigilance case was pending against the petitioner and which is still pending. After clearance of

the vigilance case he will definitely be sent for the above said training from the Assam Circle as he has already ~~xxxx~~ passed the qualifying examination. Regarding passing of a reasonable order as to why the applicant should be made Junior to the other persons who had participated in the training earlier, the case is under consideration of the contemner because filing of Review application against the judgment and order dated 02-07-97, that matter has now been kept pending till final disposal of the Review application filed by the alleged Contemner and another

5) That with regard to the statements made in para 2 of the Contempt Petition the alleged Contemner begs to state that it is not correct that he has not willfully complied with the Hon'ble Tribunal's order but the said has not been implemented in view of the filing of Review Application by the alleged Contemner before the Hon'ble Tribunal. In view of this there is no reason to initiate the contempt proceedings against the alleged Contemner as he has not committed any cont~~empt~~ willfully as alleged by the petitioner.

6) That with regard to the statements made in para 3 of the contempt petition the alleged contemner begs to state that the contemner No.2 is an Asstt. Director of legal Cell but he is not the competent authority to implement the judgment and his only duty is to assist the Chief General Manager Telecom in all the legal matters.

7) That with regard to the statements made in para# 4 of the Contempt Petition the alleged Contemner begs to state that the same is not made bona fide but the same has been mala fide.

8) That the alleged Contemner submits that he has not committed any contempt of court willfully and there is no intention of his to disobey the order of the Hon'ble Tribunal but he has not implemented the judgment in view of the fact that the important facts of the case are suppressed by the original applicant in O.A. No.59 /97 for which the alleged contemner has filed the Review Application before the Hon'ble Tribunal. It is hoped that the Hon'ble Tribunal will definitely consider the fact which has been stated in the Review application and review the judgment dated 02-07-97 for the ends of justice .

It is, therefore, respectfully prayed that the Hon'ble Tribunal will not initiate the contempt proceedings against the alleged Contemner and dismissed the Contempt petition.

And for this act of kindness, your petitioner alleged Contemner as in duty bound, shall ever pray.

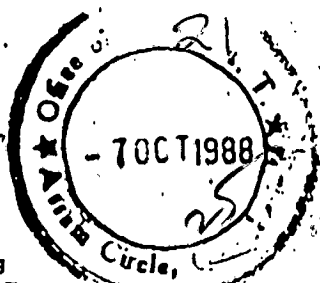

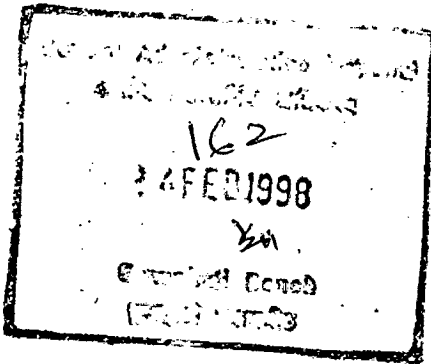

2) That the alleged Contemner No.2 fully adopt the same statements made by the alleged Contemner No.1 in reply to the show-cause notice issued to both the Contemner No.1 & 2 .

3) That after going through the judgment & order dated 02-07-97 passed by the Hon'ble Tribunal it was found that some important points of facts and points of law were not raised at the time of advancing the arguments by the learned Sr. C.G.S.C. in the case. That apart, he was also not properly briefed by the Department with regard to those points, namely, that the original applicant is an employee of the Assam Circle and served as Phone Inspector and not as Junior Telecom Officer. Before bifurcation of N.E. Circle in 2 (two) circles that is , N.E. Circle and Assam Circle the original applicant appeared in qualifying examination of J.T.O. from undivided N.E. Circle, Shillong as his name was enlisted for undergoing training of J.T.O. by the N.E. Circle. During that time though he qualified for undergoing training but he was not sent for the said training not only by the present applicant but also his other batch - mates. The original applicant opted for Assam Circle as RWA. Phone Inspector and not as J.T.O. which is a higher post than the Phone Inspector .

(Contd.)

That these facts were also suppressed by the original applicant and hence the alleged contemner has filed Review Application before the Hon'ble Tribunal against the judgment & order dated 2-7-97 passed in O.A. No. 59/97 and the said Review Application is now pending before the Hon'ble Tribunal for consideration and decision.

2) That, it may further be mentioned here that after bifurcation the J.T.O. list for Assam Circle & N.E. Circle was prepared and published by the N.E. Circle and in the said list the original applicant was included in the N.E. Circle list and his name was appeared at Sl.No. 191 and his name did not find place in Assam Circle as J.T.O. It is worth to mention in this connection that the original applicant was also appeared in the qualifying examination for J.T.O. from Assam Circle on 29-01-95. He has also been selected for undergoing the Training of J.T.O from Assam Circle but he could not be sent as vigilance case has been pending against him.

3) That with regard to the statements made in para 1 of the contempt petition the alleged contemner has no comments the same being matters of record. The alleged Contemner further begs to state that, it is not a fact that the alleged contemner has not taken steps against the order dated -2-7-97 passed in O.A.No.59/97 by the (Contd)

Hon'ble Tribunal but in fact, the alleged contemner was not in a position to send him for training of ~~xxx~~ J.T.O. as vigilance case was pending against the petitioner and which is still pending. After clearance of ~~gx~~ the vigilance case he will definitely be sent for the above said training from the Assam Circle as he has already passed the qualifying examination. Regarding passing of a reasonable order as to why the applicant should be made junior to the other persons who had participated in the training earlier, the case is under consideration of the contemner because filing of Review application against the judgment and order dated 2-7-97 that matter has now been kept pending till final disposal of the Review application filed by the alleged contemner and another.

6) That with regard to the statements made in para 2 of the contempt petition the alleged contemner begs to state that, it is not correct that he has not willfully complied with the Hon'ble Tribunal's order but the said has not been implemented in view of filing the Review Application by the alleged contemner before the Hon'ble Tribunal. In view of this there is no reason to initiate the contempt proceedings against the alleged contemner as he has ~~W~~not committed any contempt willfully as alleged by the petitioner.

7) That with regard to the statements made in para 3 of the Contempt petition the alleged contemner begs to state that, the alleged Contemner is not the authority to implement the judgment passed by the Hon'ble Tribunal on 2-7-97 in O.A. No. 58 & 59/97

is to assist the Chief General Manager Telecom in all legal matters.

8) That with regard to the statements made in para 4 of the contempt petition the alleged contemner begs to state that the same is not made bona fide but the same has been made ka mala - fide .

9) That the alleged contemner submits that he has not committed any contempt of court willfully and there is no intention of his to disobey the order of the Hon'ble Tribunal but he has not implemented the judgment in view of the fact that the important facts of the case are suppressed by the Original applicant in O.A. No. 59/97 for which the alleged contemner has filed the Review Application before the Hon'ble Tribunal. It is hoped that the Hon'ble Tribunal will definitely consider the fact which has been stated in the Review Application and review the judgment dated 2-7-97 for the ends of justice.

It is , therefore, respectfully prayed that the Hon'ble Tribunal may be pleased to close the Contempt petition/proceeding against the alleged Contemner No.2 .

And for this act of kindness, your petitioner as/ Contemner No.2 as in duty bound shall ever pray .

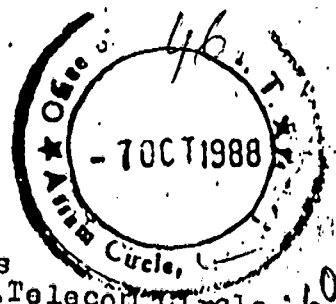


