(1) Denial of appointment to the applicant to the post of ^{Craft} ~~Cast~~ Teacher (Bengali Medium in catogory 6 under employment notice No.3/94 dt. 19.12.94 inspite of her selection to the said post.

4. The applicant declares that the subject matter is within the Jurisdiction of this Tribunal.

5. The applicant further declares that the application is within the limitation prescribed under Section 21 of the Administrative Tribunal Act.1985.

6. Facts of the Case :-

(1) That your applicant states that by an advertisement in the "The Assam Tribune" dt. 19.12.1994, the Member/Secretary, Railway Recruitment Board, Gauhati invited application for certain categories of post in the North-East frontier Railways, and the petitioner. Being a graduate with education as method subject and having a diploma in tailoring Master from the Govt. Registered Nandan Commercial College Maligaon, applied for category No.6 (Govt. ^{Graft} Teacher) Bengali Medium School under employment notice No.3/94 being qualified for the same.

A copy of the said advertisement and the the requisite testimonials of the application are annexed herewith and marked as Annexure-A, B and C respectively.

(2) The applicant was called for the written test on 9.4.95 in which her Roll No. was 810033. In the said written test she came out successful

as seen from the notice dt. 7.6.95 issued by the ~~Member~~ Member Secretary, Railway Rectt. Board, Guwahati in which her Roll No. appears in E. Category 6 (Govt. Teacher (B.M.)) and the date of Viva-Voice Test was fixed on 12.7.95 at 10.00 a.m. in the Office of the Railway Recruitment Board, Station Road, Guwahati-1.

Copy of the notice dt. 7.6:95 and Admit Cards is annexed as Annexure-D and E respectively.

3. That in the meantime by notice dt. 28.7.95 issued by the Railway Recruitment Board, Guwahati the applicant was empanelled for the post in which she applied i.e. ^{Govt} Govt. Teacher in Scale Rs.1400-2600 in category 6 against unreserved vacancy.

A copy of the notice dt. 28.7.95 is annexed as Annexure-F.

4. That while your applicant was expecting that she had already passed her written and Viva-Voice Examination for the post of Govt. Teacher. Bengali Medium, necessary appointment ~~order~~ from the Respondent authority would soon follow but to her utter surprise no appointment letter was issued in her favour till date and as a result she filed various representations on different dates before the competent authority for early

issuance of necessary appointment order in her favour in terms of her selection. In the said representations it was also stated interalia that the Respondent authority has already given appointment to other selected person in other categories and the applicant has been unfairly singled out and discriminated.

Copies of the said representations are annexed herewith and marked as Annexure-G, H, I, J, K, respectively.

7. Details of Remedies Exhausted.

There is no statutory appeal against the action of the Respondents in denying the applicants her appointment after her due selection. However, the applicant has by her representation on different dates moved the Respondents to appoint her to the post of ^{Graft} Govt. Teacher (Bengali Medium) in the North-East frontier Railways.

That at present no application in connection with her appointment to the aforesaid post is pending before any court/Tribunal.

8. Reliefs sought for and grounds:-

In the premises aforesaid, the application prays for an direction to the Respondents' to appoint

the applicant to the post of Govt. Teacher (Bengali Medium) for category 6 under employment notice No.3/94 ~~at~~ dt. 19.12.94.

GROUND.

(a) For that impugned action of the Respondents in denying the applicant her appointment to the aforesaid post after her due selection is most arbitrary, unfair, unresenable and capricious and in complete violation as of the rights ~~in~~ guaranteed to the applicant under Article 14 and 16 of the constitution of India.

(b) For that the denial of the appointment to the applicant ~~at~~ after her selection is discriminatory as much as similarly situated persons in different category under the same employment notice 3/94 has already been appointed and the said action is without any resonable basis or justification and as such denies the applicant equality before law and/or equality before law and/or equal protection under the laws.

(c) That the action of the Respondents in with holding her appointment even after her selection is an out right act of victimisation on extraneous consideration without any cogent and ~~at~~ *discernable* reasons and the said is illegal arbitrary and unfair.

(d) The actions of the Respondents have caused ~~adverse~~ adverse Civil consequences on the applicant and is in violation of the principles of natural justice and fair play and suffers from vice of arbitrariness and malafide and hence is liable to be interfere to by this tribunal in its original jurisdiction.

(e) For that the entire action of the Respondents in refusing to appoint her to the post in which she was selected without any cogent ~~reason~~ reason is unheard in law and unprecedented in service jurisprudence and is ~~shock~~ shocking to judicial conscience. The applicant has been deprived of her right to the said publicpost without any reseonable basis or justification even after her ~~final~~ selection to satisfy the whims and Eaprice of persons in power for extraneous and collateralgain.

9. Prayer.

In the premises aforesaid it is respectfully prayed that this Hon'ble Tribunal would be pleased to call for the records of the case on cause/ causes being shown and upon hearing the parties be pleased to direct the Respondents to appoint the applicant to the post of ^{Craft} ~~Govt.~~ Teacher & (Bengali Medium) in category 6 under employment Notice No.3/94 dt. 19.12.94.

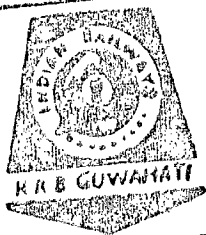

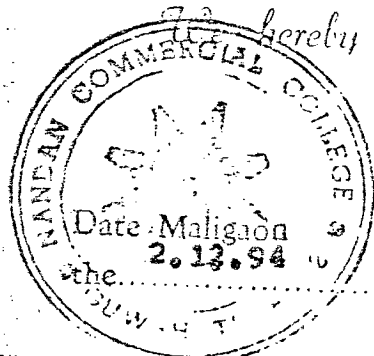

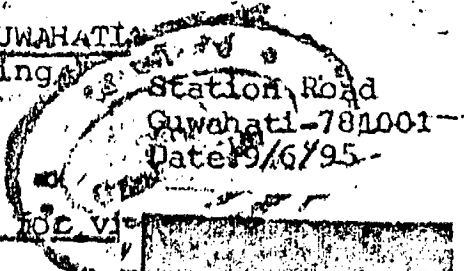
