# <u>ORDER</u>

### BY HON'BLE MR.RAKESH SAGAR JAIN, MEMBER - J

Heard Shri Pradeep Kumar Mishra counsel for the applicants and Shri S.M. Mishra counsel for the respondents.

2. Learned counsel for the applicants submits that grievance of the applicants is that vide order dated 13.8.2018 (Annexure A-1), the names of applicants have been omitted from the select list for consideration for promotion to the post of Loco Pilot Goods, although their names were earlier there as per the list annexed as Annexure A-2, for which they have already filed a representation.

- 3. Learned counsel for the applicants further submitted that the grievance of applicants might be redressed if the respondent No.2/competent authority is directed to dispose of his pending representation dated 20.8.2018 (Annexure A-6) and pass a reasoned and speaking order within a stipulated period of time. Their prayer for an interim relief not to go ahead the promotion till the disposal of representation dated 20.8.2018 (Annexure A-6) of the applicant is decided.
- In view of the limited prayer made by the applicants but without commenting anything on the merits of the case, the OA is disposed of at the admission stage itself with direction to the respondent No.2/competent authority to consider and dispose of the representation of the applicants dated 20.8.2018 (Annexure A-6) in the light of the provisions of I.R.E.M, by passing a reasoned and order within a period of three months from the date of receipt of a certified copy of the order, copy of which shall be communicated to the applicants. Till the disposal of representation, the authority may go ahead with promotion to Loco Pilot (Goods) based on the impugned order dated 13.8.2018 (Annexure A-1) keeping eleven posts vacant in respect of applicants till representation disposal of the by the respondent No.2/competent authority as per this order. No order as to costs.
