O R D E R

Heard Shri T.S. Pandey, counsel for the applicants and Shri M.K. Yadav, counsel for the respondents.

2. Learned counsel for the applicants submitted that the applicants moved this OA for grant of benefits of 6th pay Commission, which the other Tribunals, High Court of Madras and Apex Court vide their judgment approved the same in favour of the applicants. Learned counsel for the applicants further submitted that some of the applicants have also preferred a

representation before Respondent No.3/Competent Authority. However, the same are still pending with the respondents.

3. Learned counsel for the applicants also submitted that his grievance may be redressed if a direction is given to the respondents to consider and decide the representations of the applicants in the light of observations made by Hon'ble Apex Court and the Hon'ble High Court of Madras and Central Administrative Tribunal of Jabalpur Bench within a specified period of time.

4. Learned counsel for the respondents has no objection if such a direction is given.

5. On perusal of representation moved by the applicants, it appears that only some of the applicants filed the representation and this OA has been filed by 32 applicants. So it will be better that all the applicants may file their representations. Accordingly, the applicants are directed to file their representations before Respondent No.3/Competent Authority along with certified copy of order passed by Hon'ble Apex Court, Hon'ble High Court of Madras and CAT, Jabalpur Bench alongwith copy of this order within three months and thereafter Respondent No.3/Competent Authority will take a decision on the representations of the applicants in the light of observations made by Hon'ble Apex

Court and Hon'ble High Court of Madras and Central Administrative Tribunal of Jabalpur Bench within a period of three months from the date of receipt of representation alongwith certified copy of this order.

6. It is made clear that we have not expressed any opinion on the merits of the case.

7. With the above direction, the OA is disposed of at the admission stage itself. No costs.
