ORDER (ORAL)

Heard the learned counsel in the review applications and
also perused the order dated 19.07.2016 of the Hon'ble High
Court, specifically the following portion:

“We have perused the order dated 01.06.2016 passed
by the Tribunal which shows that the Tribunal did not
deem it appropriate to adjourn the matter as the counsel
was not available and since several adjournments had
already been given.

The learned counsel for the petitioner, at this stage,
craves leave to move an application for review of the order
dated 1.6.2016 before the Tribunal. It is agreed that in
case the review application is filed within two weeks, the

plea of limitation will not be raised by the respondents herein.

The petition is disposed of in terms of the statement made by the counsel for the petitioner. We make it clear that we have not expressed any opinion on the merits of the matter.”

2. This was a matter pertaining to the year 2012. When it came up for final hearing on 23.05.2016, since the learned counsel for the review applicants were not present and also not present on various other dates, we had proceeded to hear the matter in the presence of counsel for respondents Nos.1, 2, 3, 4, 8, 10 and 16.

3. In view of the fact, as stated by Shri Ajesh Luthra, that as a result of this order, some seniors, viz. private respondents No.5, 6 and 12 in the main O.A., would become junior, in the interest of justice, let the matter be re-heard. However, on the next date of hearing, no further adjournment should be allowed.

4. Accordingly, both the R.As. are allowed and the O.A. is restored to its original number and fixed for hearing for tomorrow, i.e. 05.01.2017, as Item No.2. It is made clear that no further adjournment would be granted in any case.
