ORDER (ORAL)

Mr. V. Ajay Kumar, Member (J) :

Heard the learned counsel for review applicant.

2. This Tribunal on 20.07.2017 having satisfied with the *prima facie* case made out by the applicants, directed the respondents to allow the applicants to participate in the LDCE, 2017 scheduled to be held on 30.07.2017 or any other date, provisionally, if they are otherwise eligible. The respondents were further directed not to declare their result until further order.

3. The respondents in the OA filed the instant Application seeking to review the aforesaid order dated 20.07.2017, by mainly submitting that the applicants are not eligible to participate in the examination and there are certain other persons also who are

identically placed like the applicants in the OA and if they proceed with the examination by allowing the applicants alone to participate leaving the other identically placed persons, the administration will face difficulties,

4. The issue involved is the interpretation of the Recruitment Rules. Basically when the *prima facie* case was made out, direction to permit the applicants to participate in the examination was issued that too provisionally and further it was directed not to declare the result. We do not find any error apparent on the face of the order dated 20.07.2017 and accordingly, the RA is dismissed.
