### **ORDER (ORAL)**

Heard both sides.

2. The present Contempt Petition is filed alleging violation of the order of this Tribunal in OA No.4338/2014 dated 09.12.2014 whereunder this Tribunal directed the respondents as under :-

"2. In view of the above submissions made by the applicants, we dispose of this OA at the admission stage with direction to the respondents to consider the aforesaid representation of the applicants and pass appropriate orders in the matter. They shall also consider the present OA as an additional representation on behalf of the applicants in the matter. The applicants shall be informed of their decision by reasoned and speaking order within one month from the date of receipt of a copy of this Order. No costs."

3. In compliance of the aforesaid order of this Tribunal, the respondents have passed a speaking order dated 17.08.2015 vide Annexure R-1.

4. In the circumstances and in view of the substantial compliance of the orders of this Tribunal, nothing survives in this CP. Accordingly, the CP is closed. Notices are discharged. However, applicant is at liberty to question the order now passed by the respondents, if they are still aggrieved, in accordance with law. No costs.
