#### **Mr. V. Ajay Kumar, Member (J):**

When the matter is taken up for hearing, learned counsel for the respondents, while drawing our attention to the reply filed by him and also Annexure R-1 enclosed thereto which is an order passed by the Hon'ble High Court of Delhi in WP(C) No.755/2017 dated 31.01.2017 wherein the order of this Tribunal dated 09.09.2016 has been stayed, prays for dismissal of the C.P.

2. In the circumstances and in view of the stay order of the Hon'ble High Court against the order of the Tribunal, the C.P. is closed. Notices are discharged. However, the applicants are at

liberty to avail their remedy, once the aforesaid W.P. (C) is finally decided, in accordance with law. No costs.
