**ORDER(ORAL)****Hon'ble Mr. Justice Permod Kohli**

Short prayer of the applicants in the present OA is to consider them for promotion to the post of Superintendent Central Excise by granting relaxation of two years in eligibility as prescribed under the Recruitment Rules and OM dated 25.03.1996. Consideration is also sought from the date juniors were promoted.

2. Sh. M.K. Bharadwaj, learned counsel for the applicants submits that the applicants would be satisfied if the respondents are directed to examine the eligibility of the applicants in the light of the judgment passed in OA No. 3405/14.
3. In view of this statement, this application is disposed of without commenting anything on the merits of the controversy with a direction to the respondents to examine the case of the applicants in the light of the judgment passed in OA No. 3405/2014 and pass appropriate order in accordance with law.
