### **ORDER (ORAL)**

### **MA No.58/2018**

MA No.58/2018, filed for joining together, is allowed.

### **OA No.49/2018**

2. Notice.
3. Shri R.N.Singh, the learned standing counsel for Delhi Government, who is present in Court, is asked to accept notice.
4. The grievance of the applicants in the present OA is that they were selected as TGT in the year 1984 and their names were included in the panel. Subsequently, the panel of 1984 was

cancelled. Ultimately, an SLP was preferred before the Hon'ble Supreme Court, which was converted into a Civil Appeal No.1900/1987 and directions were issued therein to make appointments from the said panel against the available vacancies. In compliance of the above directions, the applicants were appointed. Subsequently, various OAs were filed claiming seniority etc.

5. The grievance of the applicants in the present OA is for finalizing their cases for grant of Senior Scale on completion of 12 years from the date of notional fixation of their pay i.e. year 1984. The applicants have served upon the respondents legal notice dated 20.11.2017, which has not been responded till date.

6. In view of the above circumstances, we dispose of this OA, at the admission stage without going into the merits of the controversy with a direction to the competent authority to take a decision on the legal notice within a period of three months from the date of receipt of a certified copy of this order by passing a reasoned and speaking order.
