ORDER (ORAL)

Mrs. Jasmine Ahmed, Member (J) :

It is the contention of learned counsel for the respondents that they have complied with the order of this Tribunal dated 03.09.2015. They also state that the added qualifying services have been granted to them and those who have retired the retiral benefits have been granted to them i.e., to applicants no. 3, 4, 6, 7, 9 & 10.

2. Counsel for the petitioners states that the retiral benefits have not been granted to them.

3. Counsel for the respondents states that they are in the process of granting the retirement benefits to the petitioners and accordingly, we feel that substantial compliance of the judgment has been done by the respondents and if any grievances are yet remaining with the petitioners, they are at liberty to make representation to the respondents to that effect and respondents are directed to decide their representation in accordance with law.

4. Accordingly, the C.P. is closed. Notices issued to the alleged contemnors are discharged.
