ORDER (ORAL)

Heard both sides.

2. This Tribunal has disposed of the OA No.638/2015 by its order dated 17.02.2015 as under :-

"3. In the circumstances, the OA is disposed of at the admission stage, without going into the other merits of the case, with a direction to the respondents to consider the representations of the applicants, keeping in view the decisions of this Tribunal and the Honble Delhi High Court vide Annexures A-5 to A-8 and to pass appropriate speaking and reasoned orders thereon, in accordance with law, within three months from the date of receipt of a copy of this order. No order as to costs."

3. The learned counsel for the respondents submits that they have fully complied with the orders of this Tribunal and accordingly passed a speaking order vide Annexure R-1 dated 19.02.2016 and accordingly prays for dismissal of the CP.

4. In the circumstances and in view of the substantial compliance of the orders of this Tribunal, the CP is closed and notices issued to the respondents are discharged. However, the applicants are at liberty to question the order now passed by the respondents, if they are still aggrieved, in accordance with law. No costs.
