O R D E R (ORAL)

(By Hon'ble Shri V. Ajay Kumar, Member (J):-

The OA No.3623/2014 was disposed by this Tribunal on 01.12.2015 as under:-

"5. In view of the above, and also following our order dated 30.09.2015 passed in OA No.3622/2015, we dispose of the present- Application with the direction to the respondents to pass a reasoned order expeditiously, preferably within a period of three months from the date of production of certified copy of this order. However, it is made clear that we have not expressed any opinion on the merit of the issue, as, at the first instance, it is required to be examined and disposed of by the respondents by recording reasons.

6. With the above directions, the Application stands disposed of, but without costs."

2. The respondents submit that they have fully complied with the order of this Tribunal. In compliance of the order of the Tribunal, the respondent No.1 has passed an order dated 06.05.2016 and respondent No.2 has also passed an order dated 07.07.2017 and copies of both orders are produced before us.

3. In the circumstances and in view of the substantial compliance, the CP is closed. Notices issued to the respondents are discharged. No costs.
