The OA No.3621/2015 was disposed of by this Tribunal on 30.09.2015 as under:-

"5. The respondents shall take a final decision expeditiously, preferably within a period of three months from the date of production of certified copy of this order.

6. With the above order, the Original Application stands disposed of.
