**ORDER (ORAL)****By Hon'ble Mr. P.K. Basu**

Heard the learned counsel for the applicants.

2. MA 97/2016, filed for joining together is allowed.
3. MA 98/2016, filed for seeking exemption from filing translated/typed copies of the documents, is also allowed.
4. Learned counsel for the applicants submits that applicants are working as Sanskrit Teachers in Delhi Sanskrit Academy under the respondents - Govt. of NCT of Delhi and similar persons, who are in Urdu Academy, were granted 50% of the regular salary whereas the applicants have been denied. They have filed the present O.A. seeking the following relief(s):

- “(a) To declare that the applicants are entitled for all the benefits which have been granted to the Petitioners in WP (C) No.13296/2009 & 2221/2010 and direct the respondents to grant salary to the applicants at par with part time Urdu teachers from due date and release the arrears with 9% interest.
- (b) To declare the action of the respondents in not paying salary to the applicants @ 50% of the salary payable to regularly appointed TGT/PGT (Sanskrit) as illegal, arbitrary and unjustified and direct the respondents to pay to the applicants 50% of the salary payable to regularly appointed teachers.
- (c) To extend the benefits of order dated 19.11.2012 and consequential order dated

07.05.2013 to the applicants by releasing arrears of pay with interest.

- (d) To allow the O.A. with costs.
- (e) Pass such other direction or directions/order or orders as this Hon'ble Tribunal may deem fit and proper to meet the ends of justice."

5. The applicants have made several representations, the last being dated 19.10.2015 (Annexure A-1 colly.), on which no decision has been taken by the respondents so far.

6. In the circumstances, the O.A. is disposed of at the admission stage, without going into the merits of the case, with a direction to the respondents to consider the representation dated 19.10.2015 of the applicants and to pass appropriate reasoned and speaking order within 90 days from the date of receipt of a copy of this order. While deciding the matter, the respondents shall also take note of Hon'ble High Court's order dated 17.09.2010 in WP (C) No. 13296/2009 and W.P.(C) 2221/2010 and this Tribunal's order in O.A. No. 1875/2012 dated 19.11.2012. No costs.

Let a copy of the O.A. be enclosed to this order.
