ORDER (ORAL)**Justice Permod Kohli:**

These Review Petitions are directed against the order dated 05.04.2017 passed in OA Nos. 2762/2016 and 2763/2016.

2. Mr. Bhardwaj, learned counsel for the applicants, submits that there is a factual error in last three lines of para 2 of the impugned judgment. The reference is made to *order dated 06.01.2017 passed in OA No. 3084/2015*. The following is recorded:-

“2.in the light of order dated 06.01.2017 in OA No. 3084/2015, order dated 19.09.2016 in O.A. No. 3112/2013 and order dated 08.11.2016 in O.A. No. 2073/2014.”

3. It is stated that as a matter of fact, the reference to OAs is incorrect and it should have been order dated 24.08.2016 passed in LPA No. 410/2014 and other connected matters. The other side concedes to this position.

4. In this view of the matter, these Review Petitions are allowed. The sentence referred to hereinabove shall be replaced and substituted with the following:-

“2.in the light of the order dated 24.08.2016 passed in LPA No. 410/2014 and other connected matters.”
