ORDER (ORAL)**Mr. Shekhar Agarwal, Member (A)**

This contempt petition has been filed for the alleged non-compliance of order dated 25.11.2014, the operative part of which reads as follows:

"5. In the circumstances, the OA is disposed of at the admission stage, without going into the other merits of the case, by directing the respondents to consider the representation dated 07.10.2014 (Annexure A-2) and to pass appropriate speaking and reasoned orders thereon, in accordance with law, within 90 days from the date of receipt of a copy of this order. No order as to costs."

2. In compliance thereof, the respondents have filed their reply along with which, they have attached a copy of speaking order passed on 10.05.2016. Learned counsel for the alleged contemnor submitted that copies of the same have also been served on the concerned employees.

3. With the passing of the aforesaid order, we are satisfied that order of this Tribunal has been complied with. Hence, nothing survives in the CP. Accordingly, this CP is closed. Notices issued to the alleged contemnors are discharged.
