#### O R D E R (O R A L)

#### **Justice M. S. Sullar, Member (J)**

The applicant, Shri. Laxman Kumar & Others have preferred the instant Original Application (O.A) challenging their termination by the respondents. It was stated to be arbitrary and illegal, invoking the provisions of Section 19 of the Administrative Tribunals Act, 1985.

2. The respondents have refuted the claim of the applicants, filed their reply completely denying all the allegations and entitlements of the applicants and prayed for the dismissal of the O.A.

3. At the very outset, instead of arguing the matter, learned counsel intends to withdraw the main O.A, to enable the applicants to file a representation to the relevant authority for redressal of their grievances.

4. Accordingly, the O.A. is hereby dismissed as withdrawn, with the aforesaid liberty, as prayed for.



5. Needless to mention, in case the applicants file a representation, then the respondents would sympathetically consider their request in terms of their policy dated 30.08.2012 (Annexure P-3).
