ORDER (ORAL)

**Mrs. Jasmine Ahmed, Member (J) :**

Learned counsel for the respondents drew our attention to page no. 4 of the compliance affidavit filed by him on 27.09.2017 wherein we found that already notification has been issued dated 16.09.2017 as per the judgment delivered by Hon'ble Apex Court dated 24.03.2017 and the respondents have considered the case of the petitioners as per judgment passed by Hon'ble Apex Court and issued notice accordingly. Learned counsel for the respondents also stated that in the absence of any specific direction, respondents have complied with the judgment of this Tribunal as per judgment passed by the Hon'ble Apex Court.

2. We feel that the compliance affidavit is filed by the respondents is justified and accordingly the C.P is dismissed. Notices issued to the alleged contemnors are discharged. If the petitioners are still aggrieved, they are at liberty to ventilate their grievances by availing available remedies, in accordance with law.
