2. Alleging violation of the orders of this Tribunal, passed in OA No.3924/2013 on 20.01.2015, the present CP has been filed.

When this matter is taken up, it is submitted by the learned counsel for the applicants that in Writ Petition (C) No.838/2016 and batch filed against the orders of this Tribunal by the respondents, the applicants have given an undertaking that they will not press the CP till the said WP is finally decided.

4. In the circumstances, the CP is closed and notices issued to the respondents are discharged. However, the applicants are at liberty to avail their remedies, if so advised, in accordance with law, once, the aforesaid WP is finally decided by the Hon'ble High Court of Delhi. No costs.
