When this matter was taken up for hearing, learned counsel for the respondents produced an Office Order No. 73/2017-E.1 dated 26.05.2017 whereunder it was stated that the department's office order No. 32/2017-E.I dated 09.03.2017 stands withdrawn and that the pay fixation done vide order dated 23.11.2016 and 04.01.2017 refixing the pay of the concerned ASOs by giving them bunching effect stands restored.

2. Hence, in view of the substantial compliance, the C.P. is dismissed.
