Ms. Vertika Sharma, learned counsel appearing for respondents has already placed on record a copy of order dated 12.07.2017, which indicates that the judgments dated 09.05.2016 passed by this Tribunal in O.A. No.1457/2016 and dated 05.08.2016 in W.P. (C) No.6828/2016 passed by the Hon'ble High Court of Delhi have been complied with. Endorsement of the aforesaid order also indicates that the said order has been communicated to all Kendras / Stations of All India Radio for compliance.

2. Mr. M K Bhardwaj, learned counsel appearing for applicants submits that the directions of this Tribunal have been complied with only *qua* few of the applicants in the aforesaid O.A., whereas all the beneficiaries of the judgment have not been granted the consequential benefits. Ms. Vertika Sharma, learned counsel assures the Tribunal that the said judgment shall be implemented in cases of all the applicants.

3. Let the necessary directions be issued by the respondents to all the concerned Kendras / Stations of All India Radio for implementation of

the aforesaid judgment of the Tribunal within four weeks from the date of receipt of such instructions.

4. With these observations, contempt proceedings are dropped.
