ORDER (Oral)

By Mr. P.K. Basu, Member (A):

Heard both the sides.

2. MA 252/2012 filed for joining together is allowed.
3. The O.A. had been filed by the applicants, who were Senior Clerk in Delhi Milk Scheme. Their main ground was that since their nomenclature was Senior Clerk, they had not been granted the scale of Rs.1400-2300 (revised Rs.5000-8000) as other Head Clerks are drawing in other Organisations within the Ministry itself.
4. In their additional affidavit filed on 08.03.2017, the respondents have clarified as follows:

“3. That the said committee also noticed that in DMS also the post of Head Clerk was created, however, the same was subsequently abolished. However, considering the exigency of services the post of UDC carrying the special pay of Rs.35 was created and the same was re-designated as Sr. Clerk vide order dated 28.12.1989 in the scale of Rs.1400-2300 which was the pay scale of the post of Head Clerk in all subordinate offices of Govt. of India as well as DMS. The scale of Head Clerk in the subordinate offices was revised to Rs.5000-8000 in July 1998. The Head Clerk in the pay scale of Rs.1400-2300 serving in Animal Husbandry Department & Fisheries (AHD&F), Ministry of Agriculture were also granted the scale of Rs.5000-8000. However, the Sr. Clerk of DMS were neither designated as Head Clerk/Assistant nor granted the revised scale of Rs.5000-8000. Accordingly, the Committee recommended for grant of pay scale of Rs.5000-8000 (9300-34800 with grade pay of Rs.4200).

4. That although the error committed in case of Sr. Clerk, DMS due to non availability of complete details has been duly acknowledged on receipt of recommendations of Committee, however, the final decision on the basis of recommendations of the Committee constituted in the Chairmanship of Joint Secretary (Estt.) could not be taken due to pendency of O.A.”

5. In view of the above observation, since the Committee constituted for this very purpose has detected the anomaly and recommended the pay scale of Rs.5000-8000 (Rs.9300-34800 with Grade Pay of Rs.4200) for the Senior Clerks of Delhi Milk Scheme, the O.A. is allowed and the order dated 07.02.2011 is quashed and set aside, and the respondents are directed to grant the scale of Rs.5000-8000 to the applicants w.e.f. 01.01.1996 and the revised scale in the 6th Pay Commission accordingly. No order as to costs.
