### **Order (Oral)**

#### **Justice Permod Kohli, Chairman**

Shri Rajeev Kumar, learned counsel appearing on behalf of the respondents has placed on record copy of an Order dated 23.01.2018 passed by the Hon'ble High Court of Delhi in WP(C) No.10019/2017 whereby a direction has been issued that till the next date of hearing, no coercive steps shall be taken in implementation of the impugned Order dated 16.12.2016.
