ORDER (ORAL)

Justice Permod Kohli :-

On the basis of similar directions issued in different OAs to the respondents to consider the cases of the applicants in the light of the judgment of the Tribunal, referred to in the OAs, the respondents have issued Result Notice No.597 for the post of Librarian under Post Code 02/13 dated 09.11.2017, whereby all the applicants in the OAs have been declared provisionally selected and recommended for appointment. We

have also noticed that at the note, appended to the aforesaid Result Notice, it is specifically mentioned that "The result has been processed keeping in this view the eligibility conditions regarding educational qualifications, caste certificates etc. as on cut-off date i.e. 20.03.2013".

2. In this view of the matter, the directions of this Tribunal stand complied with. Nothing survives. Proceedings dropped.
