### **ORDER (ORAL)**

**By Mr. V. Ajay Kumar, Member (J)**

Heard the learned counsel for the applicant.

2. MA 470/2017 filed for joining together is allowed.
3. The applicants filed the present O.A. seeking the following relief:

“(a) to direct the respondents to extend to the applicants, the benefit of revised pay scales, on notional basis w.e.f. 01.01.1996 with actual benefit on 19.02.2003 as granted by

OM, dated 28.02.2003, issued by Respondent No.2, as has been done in the case of Shri Tapan Sutradhar, with interest thereon at such a rate as this Hon'ble Tribunal may deem fit and proper;

- (b) to grant costs of this OA to the applicants herein; and
- (c) to pass such other order or orders as may be deemed fit and proper in the interest of justice.”

4. It is submitted that the applicants preferred a representation dated 03.11.2015 ventilating their grievances, as claimed in the O.A. The respondents vide Annexure A-8 dated March, 2016 stated that the applicants' representation has been referred to the Ministry of I&B for consultation with Department of Legal Affairs and Department of Expenditure. However, till date, no final orders have been passed by the respondents.

5. In the circumstances, the O.A. is disposed of at the admission stage, without going into the other merits of the case, by directing the respondents to take a final view on the claim of the applicants and to pass appropriate speaking and reasoned orders thereon, in accordance with law, within 90 days from the date of receipt of a copy of this order. No order as to costs.
