Learned counsel for the respondents has submitted that the order of this Tribunal was challenged by the respondents before the Hon'ble High Court of Delhi vide writ petition No.9049/2014. However, the same was dismissed on 19.12.2014. The respondents have now filed SLP before the Hon'ble Supreme

Court of India in which notices have been issued in the SLP as well as on the prayer for interim relief on 09.09.2016.

In view of the aforesaid, we close this CP at this stage. Notices issued to the alleged contemnors are discharged. The petitioner, however, shall be at liberty to revive the same in case the order of this Tribunal survives after decision in the SLP.

In CP No. 489/2014 in OA 1895/2013

Learned counsel for the respondents has submitted that the order of this was challenged by the respondents before the Hon'ble High Court of Delhi vide writ petition No.9059/2014. However, the same was dismissed on 19.12.2014. The respondents have now filed SLP before the Hon'ble Supreme Court of India in which on 01.08.2016, the following order has been passed by the Apex Court:-

"Delay condoned.

Leave granted.

List this matter along with Civil Appeal No. 6359 of 2016.

Status quo, as it exists today, shall be maintained during the pendency of the appeals."

In view of the aforesaid, we close this CP at this stage. Notices issued to the alleged contemnors are discharged. The petitioner, however, shall be at liberty to revive the same in case the order of this Tribunal survives after decision in the SLP.
