Justice Permod Kohli:

As reported by the Registry, notices to all the original applicants were issued by registered post with AD on 23.08.2017. Original applicant nos. 2, 4, 7, 9-12, 15, 17-20, 22, 24-26, 31-32, 34-38, 40-42 and 44 are duly served. Notices sent to original applicant nos. 3, 28, 43 and 13 have been received back with endorsement “unclaimed”, which obviously means that they had the intimation of the notice, but they chose not to claim envelope. Notices sent to original applicants 1, 5, 6, 8, 14, 16, 21, 23, 27, 29, 30, 33 and 39 have not been received back served or otherwise. 30 days’ period of service is over. There is presumption of service. All the original applicants being served/deemed served are absent despite service.

2. Since on the last few dates, the original applicants have chosen not to appear and remained absent, it appears that they are not interested to prosecute the present OA. The OA is dismissed for default of appearance and non-prosecution.
