### **O R D E R (ORAL)**

**Mr. A.K. Bhardwaj:**

The prayer made in the present Original Application filed under Section 19 of the Administrative Tribunals Act, 1985 reads thus:-

“(a) To quash result of Senior Management Trainee – Telecom declared in the month of December 2012.

(b) To direct the respondent to declare the result of Senior Management Trainee – Telecom as per the criteria laid down in the advertisement.

(c) To direct the respondent to declare the Interview criteria as specified in MTNL Senior Management Recruitment rules 2008 after the declaring the written exam.

(d) To direct the respondent to make panel for the fulfilment of all the existing vacancies in Senior Management Trainee – Telecom.

(e) To allow OA with cost.”

2. Learned counsel for respondents submitted that the result for Senior Management Trainee declared in the month of December 2012 has been scrapped and the Original Application has become infructuous. Nevertheless, the applicant has filed M.A.No.3406/2015 for amendment in the Original Application.

3. There is no appearance on behalf of the applicant even on the revised call. In the wake, both M.A.No.3406/2015 as well as Original Application are dismissed in default and for non-prosecution. No costs.
