O.A No. 822/2018 :

2. It is the contention of counsel for applicants that the respondents are going to hold DPC very soon without considering the case of the applicants for promotion to the post of Senior Superintendent. He also stated that the applicants have already completed seven years of service in the post of Superintendent / CDPOs.

3. On query in regard to the applicants having made any representations, the counsel for applicants answered in negative. Accordingly, the applicants are directed to prefer representations to the respondents within seven days from today and as counsel for applicants stated that respondents are going to hold DPC shortly, the respondents are directed to take decision on the representations of the applicants within 15 days from the date of receipt of representations along with a certified copy of this order and till they take a decision on the representations of the applicants, the DPC shall not be convened.

4. Accordingly, the O.A is disposed of. It is made clear that nothing has been commented on the merits of the case.
