**ORDER (Oral)**

**By Mr. V. Ajay Kumar, Member (J):**

Heard the learned counsel for the applicants.

2. The learned counsel submits that he is restricting the OA only in respect of applicants No. 1 to 8 who are working as Investigator Grade-I and not pressing the OA in respect of the remaining applicants, i.e., 9 to 27. He seeks leave to avail the remedies available to them by the applicants No. 9 to 27 separately. Accordingly, MA No.1090/2018 for joining together is allowed only in respect of applicants No. 1 to 8 and with liberty to others to avail their remedies, by filing separate O.As., in accordance with law.

3. It is submitted that applicants, who are working as Investigator Grade-I, are eligible and qualified for consideration of their cases for promotion to the next higher post of Assistant Research Officer Grade-II in terms of Recruitment Rules and though the vacancies are available in the higher post, the respondents are not conducting DPCs causing loss to the applicants.

4. It is also submitted that the applicants made representations vide Annexure A-1/Colly but the respondents have not passed any orders thereon.

5. In the circumstances, the OA is disposed of, without going into the merits of the case, by directing the respondents to consider the representations of the applicants vide Annexure A-1/Colly, and to pass appropriate speaking and reasoned orders thereon, in accordance with law, within a period of 60 days from the date of receipt of a copy of this order.

6. No order as to costs.
