**ORDER (ORAL)**

**By Hon'ble Mr. V. Ajay Kumar,**

Heard the learned counsel for the applicants.

**MA No.2433/2017**

2. MA No.2433/2017, filed for joining together, is allowed.

**OA No.2269/2017**

3. The applicants, retired Accounts Officers, filed the present OA seeking the following reliefs :-

- "8.1 To direct the respondent authorities to grant to the Applicants the pay scale from the date of joining in the view of decision taken in case of "UOI and ors. v. SRI Tapan Sutradhar" and thereby grant arrears including all consequential benefits.
- 8.2 To release to the applicant the difference in pay after effecting the revisions in his pay.
- 8.3 Award Interest till the arrears are finally paid.
- 8.4 Grant cost of the application.
- 8.5 Any other consequential benefits as this Hon'ble court deems fit."

4. It is submitted that the applicants have made number of representations including Annexure A-4 (colly) representation dated 10.12.2015 ventilating their grievances to the respondents, however, the respondents have not passed any order thereon till date.

5. In the circumstances, the OA is disposed of, without going into the merits of the case, by directing the respondents to consider the aforesaid Annexure A-4 (colly) representation dated 10.12.2015 of the applicants and pass appropriate reasoned and speaking order within 90 days from the date of receipt of a copy of this order, in accordance with law. No costs.
