Mr. Justice Permod Kohli, Chairman :

MA No.2237/2016

For the reasons stated therein, MA filed for joining together in a single Application is allowed.

OA No. 2447/2016

2. Shri Arun Birbal, learned counsel appearing for respondents submits that reply is ready and same shall be filed during the course of the day. He, however, submits that the relief claimed in OA

No.2447/2016 i.e. 3rd financial upgradation (MACP) has been granted to the applicants. On examination of the reply, Shri M.K. Bhardwaj, learned counsel for applicants accepts the situation. His only submission is that the consequential financial benefits may be released within a reasonable time.

3. In this view of the matter, this OA is disposed of with a direction to the respondents to release the consequential monetary benefits of financial upgradation in favour of the applicants within a period of three months. No costs.

4. In view of the aforesaid order, no order is required to be passed in MA No.726/2017.
