ORDER (ORAL)**By Mr. V. Ajay Kumar, Member (J)**

The applicants in all these OAs, who are Drivers in Delhi Transport Corporation (DTC), filed the present O.As. seeking quashment of show cause notices/termination orders issued to them due to invalid driving licences.

2. The learned counsel for the applicant submits that the subject matter of all these OAs are squarely covered by the decision of a

coordinate bench of this Tribunal in O.A. No.2351/2015 and batch dated 26.10.2016 and, accordingly, these OAs may also be disposed of in terms of the said decision.

3. The learned counsel appearing for the respondents – DTC, while not disputing the said fact, however, submits that they have filed a writ petition against the said decision before the Hon'ble High Court of Delhi.

4. In view of the aforesaid submissions, all these OAs are disposed of in terms of the order dated 26.10.2016 in O.A. No.2351/2015 (Hari Om Singh vs. DTC & others) and batch, however, subject to the result of the writ petition filed by the respondents against the said decision.

5. In view of the above, CP Nos.467/2016, 468/2016 and 469/2016 filed in O.A. Nos.2086/2016, 2085/2016 and 2084/2016, respectively, in respect of interim orders have become infructuous and, accordingly, the same are closed. Notices are discharged.
