**ORDER (ORAL)**

**Mr. V. Ajay Kumar, Member (J) :**

Heard both sides.

2. The applicants, presently working as Stenographer Grade-I are aggrieved by the action of the respondents in not promoting them to the post of Inspector, Central Excise. It is, now, submitted by both sides that the respondents while considering the applicants as eligible for promotion to the post of Inspector, have sent them for Physical Standards/Test and also called for their vigilance clearance. It is further submitted that conducting of the DPC by the respondents for promotion of the applicants is only due as on today.

3. In the circumstances, the OA is disposed of without going into the merits of the case, by directing the respondents to consider the cases of the applicants for promotion to the post of Inspector, as per rules, by conducting the DPC as early as possible, preferably within a period of 60 days from the date of receipt of a certified copy of this order. No costs.
