### **ORDER (ORAL)**

MA for joining together is allowed.

2. Learned counsel for the applicants has submitted that the applicants were candidates for post codes 09/10, 10/10, 59/10 and 60/10 for the post of TGT (Social Science). The respondents declared the result of the same on 17.05.2016 in which only Roll Numbers of the selected candidates were shown. The respondents have neither declared the names of the candidates selected nor have they declared the marks obtained by them.

3. The applicants made a representation to the respondents on 06.06.2016. However, the respondents have not yet taken any decision on the same. Learned counsel for the applicants submitted that the applicants would be satisfied in case directions were given to the respondents to decide their representations within a given time frame.

4. Accordingly, this OA is disposed of at the admission stage itself without issuing notice to the respondents and without going into the merits of the case with a direction to them to take a decision on the representation of the applicants within a period of six weeks from the date of receipt of a certified copy of this order. They shall communicate their decision to the applicants by means of a reasoned and speaking order. No costs.
