Justice Permod Kohli:

MA for joining together is allowed for the reasons stated therein. Notice. Mr. N.K. Aggarwal, learned counsel, accepts notice for respondent.

2. Keeping in view the nature of relief claimed and the facts of the case, this OA is being disposed of at the admission stage itself without commenting on the merits.

3. The dispute in the present case relates to the seniority of the Assistant Provident Fund Commissioners in the respondent organization. A provisional seniority list was notified vide Office Memorandum dated 11.08.2016. Vide para 8 of the aforesaid provisional seniority list, objections were invited from the concerned persons within 30 days. The applicants have filed a representation dated 05.09.2016 (Annexure A/6). The grievance of the applicants is that despite filing of objections, no decision has been taken thereon. It is, however, admitted by the learned counsel for the applicants that the seniority list has not been finalized till date.

4. In view of the above circumstances, this OA is disposed of with a direction to the respondent to finalize the seniority list by taking into consideration the objections preferred by the applicants as referred to above and all other objections to the draft seniority list, within a period of four months from the date of receipt of copy of this order.
