**ORDER (ORAL)**

**Mr. V. Ajay Kumar, Member (J) :-**

When the matter was taken up for hearing, learned counsel for respondents submits that they have granted the main reliefs of regularisation of service to all the applicants in the OA and accordingly, prays for dismissal of the same.

2. On the other hand, learned counsel for applicants submits that still the claims of the applicants with regard to pension and other benefits are pending and yet to be addressed by the respondents. In the circumstances, and in view of the redressal of the main grievances of the applicants and their regularisation, the OA is disposed of. However, the applicants are at liberty to make appropriate representations with regard to any of the other grievances still remaining and on receipt of such representations, the respondents may consider the same and pass appropriate reasoned and speaking order thereon, in accordance with law, within a reasonable period. No costs.

3. Pending MAs, if any, stand disposed of.
