ORDER (ORAL)

Heard the learned counsel for the applicants.

2. MA 1846/2017 filed for joining together is allowed.
3. The applicants, who are working as Senior Divisional Medical Officers, filed the O.A. seeking the following relief(s):

- “(a) Direct the Respondents No.1 & 2 to immediately issue necessary and consequential orders granting all the benefit of the NFU Scheme as per the Sixth Central Pay Commission recommendations to all the 82 applicants/IRMS Officers of 1996 batch as mentioned in the memo of parties.
- (b) Direct the Respondents No.1 & 2 to immediately grant NFU Scheme and all the benefits accrued to 82 applicants/IRMS Officers of 1996 batch as mentioned in the memo of parties as per the recommendations of Sixth Pay Commission including monetary benefits to the 82 applicants in accordance with the recommendations of Sixth Pay Commission and also release the arrears.
- (c) Pass such other or further orders as this Hon’ble Tribunal may deem fit and proper in the facts and circumstances of this case.
- (d) Award cost of the litigation to the Applicants.”

4. When this matter is taken up for hearing, learned counsel for the applicant submits that though certain representations have been made by the applicants ventilating their grievances, however, the same were made to a wrong authority and, hence, the applicants may be permitted to make a fresh representation to the respondents.

5. In the circumstances, the O.A. is disposed of at the admission stage, without going into the merits of the case, by permitting the applicants to make appropriate representation ventilating their grievances to the respondents within two weeks from the date of receipt of a certified copy of this order, and on receipt of such a representation from the applicants, the respondents shall consider the same and pass appropriate speaking and reasoned orders thereon, in accordance with law, within 90 days therefrom. No order as to costs.

Let a copy of the O.A. be enclosed to this order.
