**ORDER (ORAL)**

Heard the learned counsel for the applicants and Shri Hanu Bhaskar, who appears on behalf of the respondents on advance notice.

2. MA 2035/2017 filed for joining together is allowed.
3. The applicants, who are working as Constables/Head Constables, filed the O.A. seeking the following relief(s):

“(a) Direct the respondents to re-fix pay of the Applicants in the revised Pay Structure in minimum pay of Rs.6460/- in PB-1 + Grade Pay of Rs.2000/- = 8460) with effect from 01/01/2006 along with all arrears of pay;

- (b) Pass such other order(s) or direction(s) as this Hon'ble Tribunal may deem fit and just in the interest of justice."

4. It is submitted that the applicants made representations vide Annexure A/4 (Colly.) to the respondents ventilating their grievances. However, the respondents have not passed any orders thereon till date.

5. In the circumstances, the O.A. is disposed of at the admission stage, without going into the merits of the case, by directing the respondents to consider Annexure A/4 (colly.) representations of the applicants and to pass appropriate speaking and reasoned orders thereon, in accordance with law, within 90 days from the date of receipt of a copy of this order. No order as to costs.
