2. The applicants, who are working in various capacities under the ESIC Hospitals, filed the present O.A. seeking the following reliefs:-

“(i) Direct the respondents to hold a cadre review in terms of the office memorandum dated 17.07.2015 for the post of Medical Laboratory Staff of ESIC Hospitals and amend the recruitment rules as a consequence to holding cadre review.

(ii) Direct the respondents to fix the Grade pay of Lab Assistants at Rs.2,800/- as available in respect of all the Lab Assistants in the other Central Government Organizations, and thus, grant the applicants grade pay Rs.2800/- after holding the cadre review in terms of the O.M. dated 17.07.2015. Similarly grant the Lab Technician/Blood Bank Technician/Blood Bank Lab Technicians, Senior Lab Technicians and Senior Technical Assistants their respective pay scales after their re-designation in terms of the office memorandum dated 17.07.2015.

(iii) Direct the respondents to conduct the DPC in terms of the amended recruitment rules and grant all consequential benefits to the Applicants w.e.f. 17.07.2015 wherefrom their counterparts in other Governments hospitals have been granted such benefits including benefits relating to grant of ACP and MACP by counting their length of service as per the

circular dated 17th July 2015 (as relief consequential to prayer a and b above).

(iv) Direct the Respondents to pay costs to the Applicants."

3. It is submitted that the applicants have made number of representations vide Annexure A-8 (colly.) ventilating their grievances to the respondents. However, no order has been passed thereon till date.

4. In the circumstances, the O.A. is disposed of at the admission stage, without going into the merits of the matter by directing the respondents to consider Annexure A-8 (colly.) representations made on behalf of the applicants and pass a speaking and reasoned order within ninety days from the date of receipt of a copy of this order, in accordance with law. No costs.

5. Let a copy of this O.A. be enclosed to this order.
