Heard both the sides.

2. The applicants, who have originally filed O.A. No.58/2015,
withdrew the same in view of rejection of their claim by the

respondents during the pendency of the O.A., with liberty to file a fresh O.A. on the same cause of action.

3. The applicants without questioning the said speaking order dated 13.10.2015 filed the instant O.A. again seeking benefit of various decisions of this Tribunal, though the respondents distinguished the applicants from that of the applicants in the said decisions by giving reasons vide their speaking order dated 13.10.2015.

4. In the circumstances and in view of the submission made by the learned counsel for the applicants, the O.A. is dismissed as withdrawn with liberty as was permitted by this Tribunal vide order dated 21.08.2017 in O.A. No.58/2015. No order as to costs.
