Justice Permod Kohli, Chairman:

Shri S. M. Arif, learned counsel for the respondents submits that the respondents have taken a decision to grant the relief claimed by the applicants. His submission is that since large number of officer are involved, and the review DPC is also to be convened, the respondents need sufficient time to complete the process. Otherwise also, the issue is covered by the judgment dated 02.11.2015 passed by this Tribunal in OA No.4283/2013 in the case of ***Mr. U. K. Sikri and others vs. Union of India and Others.***

2. In this view of the matter, and the submissions made by learned counsel for the respondents, this Application is disposed of with the direction to the respondents to complete the process of consideration and grant the relief prayed for by the applicant within a period of four months from the date of receipt of certified copy of this order.
