**ORDER (ORAL)**

**By Mr. V. Ajay Kumar, Member (J)**

Heard the learned counsel for the applicants.

2. M.A. 2752/2015, filed under Rule 4(5)(a) of C.A.T. (Procedure) Rules, 1987 for joining together, is allowed.

3. The applicants, who are working as Assistants/Section Officers/Deputy Director, filed the present O.A. seeking the following relief(s):

“(i) That the Hon’ble Tribunal may graciously be pleased to pass an order directing the respondents to re-fix the pay of the applicants with reference to the scale of Rs.7450-11500 as on 1.1.2006 and then fix in the PB-2 + GP 4600/- with all the consequential benefits including the arrears of difference of pay and allowances.

- (ii) That the Hon'ble Tribunal may further graciously be pleased to pass an order directing the respondents to fix the pay of the applicants, **after granting the benefit of one increment for a period of two years of completed service put in by them prior to 01.01.2006 be granted, as provided in Instructions regarding fixation of pay in Gazette Notification No.GSR 622(E) dated 29.8.2008 issued by the Ministry of Finance** with all consequential benefits including the arrears of difference of pay and allowances as held and directed by the Hon'ble Tribunal in O.A. No.2835/2011.
- (iii) Any other relief which the Hon'ble Tribunal deem fit and proper may also be granted to the applicants."

4. It is submitted that the applicants made number of representations ventilating their grievances to the respondents. However, the respondents have not passed any orders thereon till date.

5. It is also submitted that the 3<sup>rd</sup> respondent has referred the matter to the 2<sup>nd</sup> respondent – DOPT, which is evident vide Annexure A/10, dated 25.09.2012 and Annexure A/11, dated 13.03.2012.

6. The learned counsel further submits that the claim of the applicants is squarely covered by a decision of this Tribunal in O.A. No.2835/2011 and batch, dated 22.12.2014.

7. In the circumstances, the O.A. is disposed of at the admission stage, without going into the merits of the case, by



directing the respondents to take a final view in the matter, keeping in view the decision of this Tribunal in O.A. No.2835/2011 and batch, dated 22.12.2014, and to pass appropriate speaking and reasoned orders, in accordance with law, within four months from the date of receipt of a copy of this order. No order as to costs.
