ORDER (ORAL)

Heard learned counsel for the parties.

2. MA No.3313/2017 filed for joining together is allowed.
3. Applicants, who are presently working as Assistant Pump Drivers with the respondents – Delhi Jal Board, are seeking the following reliefs:

“a) Direct the respondents to remove the anomaly in the pay of applicants and step-up/refix their pay at par with their juniors and counterparts APDs and quash the order dt. 21/10/2016 passed by respondents.

b) Direct the respondents to grant 3% increment in the pay of applicants as per their office order and consider the applicants for next promotion as PD if they are otherwise eligible.

c) All consequential benefits may be granted to the Applicants.

d) Any other or further order(s)/relief(s), directions which this Hon'ble Tribunal may deem fit and proper in the interest of justice, for fixation of pay of the applicants.

e) Cost of the proceedings be awarded in favour of the applicants and against the respondents.”

4. The main grievance of the applicant is that their claim was rejected by the respondents vide Annexure A-1 order which is not a speaking order and no reason for rejection is given. A bare perusal of this order, support the submission of the applicants.

5. The representations filed along with OA made by the applicants are also, in our view, not exhaustive. In the circumstances, the OA is disposed of without going into the merits of the case by permitting the applicants to make an appropriate detailed representation to the concerned authority ventilating their grievances within one week from the date of receipt of a copy of this order and on receipt of such representation from the applicants, respondents shall pass a speaking and reasoned order within 60 days therefrom, in accordance with law.
