### **ORDER (ORAL)**

**By Hon'ble Mr.V. Ajay Kumar, Member (J)**

Heard the learned counsel for the applicants.

2. MA No.2781/2015 filed for joining together is allowed.
3. The applicants, who are working as employees in various capacities under the respondents, filed the present OA seeking the following reliefs:-

- “(i) direct the respondents to count 50% of pre-regularization services of the applicants for all purposes, including seniority and consequential benefits;
- (ii) pass such other order/s as may be deemed fit and proper.”

4. It is submitted that the applicants have made number of representations and also got issued a legal notice (Annexure A-3 dated 25.05.2010) ventilating their grievances to the respondents, however, the respondents have not passed any order thereon till date.

5. In the circumstances, the OA is disposed of, at the admission stage, without going into the merits of the case, by directing the respondents to consider the legal notice (Annexure A-3 dated 25.05.2010) and pass appropriate reasoned and speaking order within 90 days from the date of receipt of a copy of this order, in accordance with law.

6. No order as to costs.
