ORDER (ORAL)

Heard Shri Sachin Chauhan, learned counsel for the applicants and Shri K.M. Singh, learned counsel who appeared on behalf of the respondents No.1, 2 and 4 on receipt of advance notice.

2. MA 4506/2017 filed for joining together is allowed.
3. The applicants filed the O.A. seeking the following relief(s):

“(i) To direct the respondents to convene the Departmental Assessment Board under in-situ rule for promotion of non medical scientists from S-IV level to S-V level in a time bound manner based on the vacancies arises on 1st January and 1st July every year (in accordance of RR of non-medical scientists) since the year 2009-10 and if promoted then promotion to be given with retrospective effect with all consequential benefits as per judgment of Hon’ble Delhi High Court judgment dated 13.3.2007 in WPC No.18684/2005 which further being affirmed by Hon’ble Apex Court vide judgment 16.2.2012 in case of UOI Vs. Dr. Ashwani Kumar in Special Leave Appeal (C) No.24577-24578/2007.

Or/and

(ii) To pass any such other order as this Hon’ble Tribunal may deem fit and proper in the facts and circumstances of the case.”

4. It is seen from the documents of the respondents themselves that the claim of the applicants had been accepted by the respondents. However, they could not conduct the required DPC

due to certain administrative issues, though the DPC was to be conducted way back in 2011 itself, even as per the respondents.

5. In the circumstances, the O.A. is disposed of at the admission stage itself, without going into the other merits of the case, by directing the respondents to consider the claim of the applicants and to take appropriate action as per the rules and to pass appropriate reasoned and speaking order thereon, within four months from the date of receipt of a copy of this order. No order as to costs.
