**ORDER (ORAL)**

**Mr. V. Ajay Kumar, Member (J) :-**

When the matter was taken up for hearing, it is noticed that though the impugned transfer order is common for all the applicants, but as admitted by the learned counsel for applicant himself, the facts of each of the applicants are different and since they have joined on different dates and now transferred to different Directorates and the personal difficulties of each of the applicants are also different and they have preferred different representations in addition to common representations, the Misc.

Application No.4523/2017, seeking joining together in a single OA is dismissed.

2. In view of the above circumstances, the OA is also dismissed. However, the applicants are at liberty to avail their remedies, in accordance with law, by filing individual OAs, if they are so advised. No costs.
