ORDER (ORAL)

By Hon'ble Mr.V. Ajay Kumar, Member (J)

Heard the learned counsel for the applicants.

2. MA No.4404/2015, filed for joining together, is allowed.

3. The applicants, who are working in various capacities, i.e. Mali, Pump Operator and Safai Karamchari under the respondents, filed the present OA seeking the following reliefs:-

“(A) Direct the Respondents No.1 & 2 to pay the same pay-scale after the 1st and 2nd ACP as is being granted to similarly placed employees working in Respondent No.3, which issue already stands adjudicated by this Hon'ble High Court of Delhi and this Hon'ble Tribunal and therefore grant benefit of judgment passed by the Hon'ble High Court of Delhi dated 01.03.2012; and

(B) Direct the Respondents No.1 & 2 to pay the same pay-scale after the 1st and 2nd ACP alongwith all upto date arrears as is being granted to similarly placed employees working in Respondent No.1 & 2 who were parties to the earlier TAs and Writ Petitions; and

(c) Pass any other appropriate order or relief which this Hon'ble Tribunal deems fit and proper.”

4. It is submitted and stated in Para 4.13 of the OA that only some of the applicants have made a representation dated 05.11.2015, Annexure A-9 (colly) ventilating their grievances to the respondents, however, the respondents have not passed any order thereon till date.

5. In the circumstances, the OA is disposed of, at the admission stage, without going into the merits of the case, by permitting all the applicants to file appropriate representations ventilating their grievances to the respondents within two weeks from the date of receipt of a copy of this order and on receipt of such representations, the respondents shall consider the same including Annexure A-9 (colly) representation dated 05.11.2015 and

pass appropriate reasoned and speaking orders within a period of 90 days there from, in accordance with law. No order as to costs.

Let a copy of the O.A. be enclosed to this order.
